2. SEN (Special Education Needs and disabilities)

SEN funding is received by the Local Authority as the High Needs Block element of the Dedicated Schools Grant. The High Needs Block allocation in 20/21 is £22,924,097. The funding is spent in the following areas:

- Special School places + Top-up funding based on individual child's needs
- Pupil Referral Unit
- Mainstream Additional Resource Provision funded at a fixed amount per place
- Mainstream Pre and Post 16 School Based and Post 16 FE College top-up funding based on individual child's needs (both in and out of borough)
- Non-Maintained Special School and Independent Specialist Provision placements
