## **Request:**

21/01272/TELGDO Proposed 15-metre Phase 8 Monopole

I refer to the matter, recently brought to my attention, concerning the proposed erection of a 15 metre 'Phase 8 monopole' mast, radiating electromagnetic energy at an unspecified frequency and power, to be sited in the Beaumont Park housing estate.

Whilst I do not live there, and have no comments concerning the negative visual impact of the proposal, my child spends a significant amount of time in a property close to the proposed site of the mast, in the care of a registered child minder. I am, consequently, concerned about the probability of physical harm to my child arising from an increased exposure to harmful non-ionising radiation emanating from the mast, which, I believe, will be less than 500 metres from the property.

I note that, in order to assuage the objection of local residents to the visual impact of the proposal, the height of the mast has been reduced from 18 to 15 metres. The probability is that, in order to compensate for the reduced height of the mast, the radiated power will be increased. This will cause the electromagnetic radiation to be intensified in those areas close to the installation. There are many studies of health problems associated with areas close to such masts, which are believed to be a consequence of non-ionising radiation (as opposed to thermal) effects. Further, it is, probably, the case that children are particularly at risk.

Consequently, I wish to make a request, under the terms of the Freedom of Information Act 2000, for you to disclose to me any discussions, and their results, you may have had with the Applicant regarding health issues. I also request that you provide copies of any documentation, relating to the hazard to health posed by this proposal, that may be in your possession.
