I've read through the nomination and it looks valid. - 3. Perhaps an informal call (I can undertake to see if the nominator knows the process)

We will have to pay for the land search and yes there will have to be a legal charge on the deeds if it goes onto the list. I'm not sure on the building survey I will come back to you on this.
