As permitted under the Freedom of Information Act 2000, I would like to request the following information from your local authority:

- Whether your local authority provides a pest control service?
Yes
- How much the council spent on reducing pest infestation in each year since 2009-10?

Information is not available to determine annual spend on reducing or preventing pest infestation since 2009-10. Nevertheless, the figures shown below reflect the net operational annual spend for providing an Environmental Protection service for each financial year (1st April to 31st March), which incorporates all Pest Control activities such as dealing with rats, mice, cockroaches and bed bugs as well as Dog Warden services.

Since 2013/14 – 6495 jobs each requiring between 1 to 4 visits, depending on the pest being dealt with.
