Any user of the Household Waste Recycling Centre can be asked to prove they live in the Borough through providing, for example, a utility bill or other documents. They may also be asked to sign a Statutory Disclaimer for confirming that they are a resident and that the waste is their household waste. From July very large vehicles, such as Luton type vans, tippers and long trailer will be banned from the site to ensure safe operations. In the autumn anyone wanting to dispose of waste using a van or with a trailer or any liveried vehicle will have to apply for a permit for each visit.
