I'm writing to request disclosure of information under the terms of the freedom of information act.

My request relates to Adoption Support Funding.

I would like to request the following;

 How many applications for funding awards from the Adoption Support Fund has your council received during the financial years 2015-16 and 2016-17?

2015-16 12 Applications

2016-17 60 Applications

ASF funding applications and awards May 2015 - 5th October 2016

 How many applications for Adoption Support Fund awards in excess of £5,000 were received between the introduction of the fund in May 2015 up until 5th October 2016 when the 'Fair Access Limit' was introduced?

For the period May 2015 to March 2016, North Tyneside Council received, approved and applied to the ASF on behalf of adoptors for 6 families, where claims exceeded £5,000 per family (it is not possible to provide the number of claims per child for this period, as some claims were made for sibling groups).

For the period April 2016 to 5th October 2016, North Tyneside Council received, approved and applied to the ASF on behalf of adoptors for 9 children, where cumulative claims exceeded £5,000 per child.

All of these 15 claims were approved by the Adoption Support Fund.

 How many applications for Adoption Support Fund awards in excess of £5,000 were approved by your council between May 2015 and 5th October 2016?

The total cost of the 15 applications was £109,795.14, which was fully funded by the Adoption Support Fund.
