4. Executive summary (taken from written report)

On 17th February 2023 the Authority was invited to present an indicative bid to The Department of Business, Energy and Industrial Strategy (BEIS) (now Department of Energy Security and Net Zero) under the Home Upgrade Grant Phase 2 (HUG2) to improve the energy efficiency of "off gas" properties in the borough. Subsequently the Authority was notified that an amount of £621,000 could be made available to support the improvement of 30 homes between 2023 and 2025.

The award of grant was conditional on the Authority entering into a Memorandum of Understanding (MOU) with Department of Energy Security and Net Zero to allow the drawdown of funding and project mobilisation. Such a Memorandum of Understanding was duly entered into on 20 April 2023.

This report deals with the subsequent procurement and appointment of a delivery partner to deliver the qualifying energy efficiency measures and the entering into of the Grant Funding Agreement with E.ON Energy Solutions. This procurement was included in the Procurement Plan 2023/24 that was approved by Cabinet on 27 March 2023 and which gave delegated authority to the Director of Housing and Property Services to commence the procurement exercise and to award a contract to the successful bidder in accordance with UK public procurement legislation.

An existing compliant procurement framework has been utilised to appoint E.ON Energy Solutions as an appropriate delivery partner.

Negotiations for a Grant Agreement with Eon Energy Solutions have now been concluded to the satisfaction of all parties.
