

## Record of Delegated Executive Decision(s)

Traffic Regulation Order – waiting restrictions, Back Front Street, Tynemouth.

### 4. Executive summary (taken from written report)

On 21 March 2023 the Director of Regeneration and Economic Development authorised

- (1) that notices for the proposal should be prepared and advertised in line with relevant statutory requirements; and
- (2) that, in the event that no objections were received following the period of consultation, that the circumstances do not warrant the holding of a local inquiry; and
- (3) that if no objections were received following the period of consultation required by statute, the Traffic Regulation Order shall be made.

The notices were prepared and advertised in accordance with the statutory requirements and no objections were received during the statutory advertising period.

Therefore, the circumstances do not warrant the holding of a Public Inquiry and the Traffic Regulation Order (TRO) should be made for the introduction of 'no waiting at any time' parking restrictions on Back Front Street, Tynemouth, in accordance with section 1.5.2 and Appendix 1 of the Delegated Decision Report of the 21 March 2023.

## 5. Alternative Options considered

### Option 1

To endorse recommendation (3) as set out in paragraph 1.2 of the 21 March 2023 Delegated Decision report – that the Traffic Regulation Order shall be made for the introduction of ‘no waiting at any time’ parking restrictions on Back Front Street, Tynemouth.

### Option 2

Not to endorse recommendation (3) as set out in paragraph 1.2 of the 21 March 2023 Delegated Decision report – that the Traffic Regulation Order shall be made for the introduction of ‘no waiting at any time’ parking restrictions on Back Front Street, Tynemouth.

Option 1 was the recommended option.
