### PART 1

#### 1.1 **Executive Summary:**

The Countryside and Rights of Way Act 2000 requires that the definitive map and statement (DM&S) is continually updated. A number of routes were identified within the Seaton Burn area and the associated unopposed orders require confirmation.

#### 1.2 Recommendation(s):

It is recommended that:

The Head of Law and Governance confirms the unopposed definitive map modification and public path orders for the Seaton Burn Area see Appendix 1 attached with copies of previously signed, unopposed Orders.

#### 1.3 Information:

#### Background

In accordance with LG67 within the Council's Constitution and Delegation Scheme the Senior Manager of Legal Services and Information Governance has the authority to confirm unopposed definitive map modification and public path orders within the Borough.

As set out above the Authority is required, by virtue of the Countryside and Rights of Way Act 2000 to update the DM&S to ensure the particulars contained in the map and statement are up to date. Theprocess has started in the North West and will continue this process throughout the Borough in the coming years.

As is due process in legislation the Orders are first drafted and signed, they are then placed on site and in the local press. The public then have 42 days to object. No objections were received in relation to any of the aforementioned paths.

The reference codes and definitive statements have also been updated to better reflect the current line of each path on the ground, these can be seen in the Appendix and the attached Orders.

The paths in question are:

Seaton Burn 1: Upgrading whole of footpath to bridleway

Seaton Burn 1, 2 and 6: Update definitive statement

Seaton Burn 3: Upgrading section of footpath to bridleway

Seaton Burn 4 & 5: Record as footpath & bridleway respectively

LB36: Extinguish

As no objections have been received in relation to the Orders it is now requested that the Orders are confirmed. Once this Delegated Decision is signed and recorded the attached Notice of confirmation will be published on site, available for inspection within the Council offices and published in the local press in the same way as the Orders were advertised.

### 1.4 Decision options:
