## 4. Executive summary

An urgent decision is sought from the Elected Mayor to consent to the award of contract to appoint the contractor for the Wallsend Customer First Centre (CFC) Community Hub project to bring Northumbria Police and Wallsend's drug and alcohol unit into the building.

At its meeting on 10 December 2012, Cabinet agreed approval for the refurbishment of the existing Wallsend building to transform it into one of the Authority's key town centre CFCs.

External funding has since been obtained to bring in further partners to enhance the Wallsend CFC Community hub offer. This includes a Northumbria Police office to the ground floor and the relocation of Wallsend's drug and alcohol unit to part of the second floor.

A tender progressed utilising the Authority's existing Framework of contractors. All three submissions included projects costs above the £500k threshold, which would usually require Cabinet approval to undertake a procurement exercise, hence the need for an urgent decision to be taken prior to the next scheduled Cabinet meeting.

# 5. Alternative Options considered

Not to provide consent to the award of contract as identified at appendix 1 within the main report.

This would make it necessary for the Authority to begin a new procurement process and explain to the successful tenderer the reasons why the contract was not awarded following a compliant process.

## 6. Decision(s)

Approval is given to (1) the retrospective undertaking of a procurement exercise in relation to the Wallsend Customer First Centre (CFC) Community Hub project and (2) authorise the Head of Commissioning and Asset Management to award the contract to the bidder as set out at Appendix 1 within the main report who represents the most economically advantageous tender.
