- (3) that if no objections were received following the period of consultation required by statute, the Traffic Regulation Order shall be made.

Therefore, the circumstances do not warrant the holding of a Public Inquiry and amendments should be made to the existing Traffic Regulation Order (TRO) associated with the permit parking scheme on Silverbirch Drive, Camperdown.
