On 23 November 2023 the Director of Regeneration and Economic Development authorised;

- that notices for the proposal to make a Traffic Regulation Order (TRO) for the introduction of a no entry except cycles restriction at the northern end of Stanton Road, Shiremoor should be prepared and advertised in line with relevant statutory requirements;
- (2) that in the event that no objections are received following the period of consultation required by statute, and that the circumstances do not warrant the holding of a Public Inquiry; and
- (3) that if no objections are received during the statutory period of consultation, the Traffic Regulation Order shall be made.

The notices were prepared and advertised on accordance with the statutory requirements and no objections were received during the statutory advertising period.
