## **4. Executive summary** (taken from written report)

On 21 September 2022, the Investment Programme Board approved the Director of Housing and Property Services submitting a bid for £1.2 million 'matched funding' to the social housing decarbonisation fund (Wave 2) (SHDF). This is a government initiative to support the social housing sector and provide the Authority with a 50% contribution towards energy installations that improve the energy efficiency of homes in the borough.

On 20 March 2023, the Authority was notified that its application was successful and has secured an award of £1,211,508.79 to deliver improvements such as Solar PV installations and Internal/External wall insulation to Authority owned housing stock across the borough. The award of grant was conditional on the Authority meeting a deadline of the 24 April 2023 to submit the award documentation to the Department for Business, Energy and Industrial Strategy (BEIS). An extension to this has been requested with BEIS to allow time for the Authority's approval process to be completed however, a response to this request is still awaited.

This report requests that the Director of Housing & Property Services enter into a Grant Funding Agreement (GFA) and Grant Letter Offer (GLO) on behalf of the Authority, to accept the grant award of £1.2m
