### **5. Executive summary** (taken from written report)

This Record of Decision relates to the approval given by the Cabinet Member for Environment to introduce 'no waiting at any time' and 'school keep clear' (Monday to Friday between 8:15 – 9:15am and 2:30 – 4:30pm) restrictions on sections of Hotspur North, Field Court, Parkside View, Willow Grove, Dene View and Burn Walk in the vicinity of Backworth Park Primary School and to set aside four objections received to the proposal.

- (1) set aside the objections in the interests of discouraging indiscriminate and obstructive parking thereby improving road safety for all road users and facilitating more sustainable travel to Backworth Park Primary School; and
- (2) determine that the Traffic Regulation Order should be made unchanged.

# 8. Reasons for the Decision(s)

Regarding the objections from Ms R; Ms S; and Ms G & Mr C – the Cabinet Member for Environment noted that the waiting restrictions would improve visibility and access at the junction of Hotspur North and Parkside View in line with the Highway Code and that existing visitor parking bays would continue to be available. The Cabinet Member for Environment further noted that that there was currently an arrangement in place for the car park at a nearby public house to be used as a park and stride facility for the school.

Regarding the objection from Mrs H – the Cabinet Member for Environment noted that the waiting restrictions would improve visibility and access at the junction of Hotspur North and Parkside View in line with the Highway Code and that existing visitor parking bays would continue to be available.
