4. Executive summary (*taken from the written report – see link below*)

On 1 November 2022 the Director of Regeneration and Economic Development authorised

- (1) that notices for the proposal should be prepared and advertised in line with relevant statutory requirements;
- (2) that in the event that no objections were received following the period of consultation required by statute, that the circumstances do not warrant the holding of a Public Inquiry; and
- (3) that if no objections were received following the period of consultation required by statute, the Traffic Regulation Order shall be made.

The notices were prepared and advertised in accordance with the statutory requirements and no objections were received during the statutory advertising period.

Therefore, the circumstance does not warrant the holding of a Public Inquiry and the Traffic Regulation Order (TRO) should be made for the introduction of 'no waiting at any time' parking restrictions on Alnwick Avenue, North Shields, in accordance with section 1.5.2 of the Delegated Decision Report of the 1 November 2022.

5. Alternative Options considered

Option 1

To endorse recommendation (3) as set out in paragraph 1.2 of the 1 November 2022 Delegated Decision report - that the Traffic Regulation Order shall be made for the introduction of 'no waiting at any time' parking restrictions on Alnwick Avenue, North Shields.

Option 2

Not to endorse recommendation (3) as set out in paragraph 1.2 of the 1 November 2022 Delegated Decision report - that the Traffic Regulation Order shall be made for the introduction of 'no waiting at any time' parking restrictions on Alnwick Avenue, North Shields.

Option 1 was the recommended option.
