Traffic Regulation Order – pedestrian crossing, Hartington Road, North Shields.

4. Executive summary (taken from written report)

On 06 July 2023 the Director of Regeneration and Economic Development authorised

- (1) that notices for the proposal should be prepared and advertised in line with relevant statutory requirements; and
- (2) that, in the event that no objections were received following the period of consultation, that the circumstances do not warrant the holding of a local inquiry; and
- (3) that if no objections were received following the period of consultation required by statute, the Traffic Regulation Order shall be made.

The notices were prepared and advertised in accordance with the statutory requirements and no objections were received during the statutory advertising period.

Therefore, the circumstances do not warrant the holding of a Public Inquiry and the Traffic Regulation Order (TRO) should be made to introduce a zebra crossing on Hartington Road, North Shields in accordance with section 1.5.2 and Appendix 1 of the Delegated Decision Report of the 06 July 2023.

5. Alternative Options considered

Option 1

To endorse recommendation (3) as set out in paragraph 1.2 of the 06 July 2023 Delegated Decision report – that the Traffic Regulation Order shall be made for the introduction of a zebra crossing on Hartington Road, North Shields.

Option 2

Not to endorse recommendation (3) as set out in paragraph 1.2 of the 06 July 2023 Delegated Decision report – that the Traffic Regulation Order shall be made for the introduction of a zebra crossing on Hartington Road, North Shields.

Option 1 was the recommended option.

- (1) To confirm that no objections were received during the statutory advertising period relating to the proposal;
- (2) That the circumstances do not warrant the holding of a Public Inquiry; and
