- (3) that if no objections were received following the period of consultation required by statute, the Traffic Regulation Order shall be made.

Therefore, the circumstances do not warrant the holding of a Public Inquiry and the Traffic Regulation Order (TRO) should be made to introduce a zebra crossing on Hartington Road, North Shields in accordance with section 1.5.2 and Appendix 1 of the Delegated Decision Report of the 06 July 2023.
