#### **4. Executive Summary**(To be taken from written report)

The Chair of the Health & Wellbeing Board has been notified by NHS England of an application to merge two pharmacies. It is proposed that the pharmacy operated by Boots UK Ltd at 95-97 Park View, Whitley Bay be consolidated onto the site of the pharmacy at Unit 15 Park View Shopping Centre, Whitley Bay, also operated by Boots UK Ltd. A copy of the application is attached.

The Health & Wellbeing Board has a statutory duty to make a statement or representation within 45 days stating whether the merger would or would not create a gap in service provision. NHS England will then convene a panel to consider the application and any representations made.

The Board has previously authorised the Director of Public Health in consultation with the Chair of the Board to decide whether to make a representation. It was also agreed that all members of the Board would be consulted on any applications prior to any decision. I have advised the Board members that this merger is not likely to have any impact on meeting the needs of the population.

I have consulted members and received the following comments:

I have no objection to this merger – Councillor Muriel Green

Living in W Bay i would agree that it would make no impact. There are two further Boots pharmacies still serving W Bay should this merge happen – Dean Titterton, YMCA

No issues from us as it doesn't create a gap in pharmacy services – Dawn McNally, Age UK North Tyneside

No issues from Healthwatch assuming they will talk to their regular users about this move. There is an independent pharmacy across the road too. Paul Jones , Healthwatch
