NHS funded arrangements

The Integrated Care Board (North Tyneside place) has agreed the rates as set out in this document for:

- Continuing healthcare placements and packages of care where the ICB is lead commissioning these services. At present the Local Authority is making payments for these services on behalf of the ICB.
- S117 funded placements and packages of care, where these are joint funded by the Local Authority and the ICB, where the Local Authority is case managing, lead commissioning and making payments in full.
- Shared funding packages of care, where these are joint funded by the Local Authority and the ICB, where the Local Authority is case managing, lead commissioning and making payments in full.

Residential – LD/MH	Variable rate – dependent on need and additional support required over base rate. Base rate range – £692.53 to £750.14
Residential – Younger Physical Disability	Variable rate – dependent on need and additional support required over base rate. Base rate range – £798.23 to £1330.45

For specialist placements where there is not a standard fee level / cost in place, increase of 8.97% to be applied to individual cost lines.

Additional cost at some day services for meal / lunch.
