At its meeting on 18 September 2023 Cabinet agreed to extend for a further period of 3 year the Public Spaces Protection Orders ("the PSPOs") made by the Authority in 2017, namely, The Council of the Borough of North Tyneside (Dog Fouling of Land) Public Spaces Protection Order 2017; The Council of the Borough of North Tyneside (Dog Control) Public Spaces Protection Order 2017 and The Council of the Borough of North Tyneside (Consumption of Alcohol) Public Spaces Protection Order 2017 ("the original Orders"). Cabinet also agreed at that meeting to authorise the Head of Law in consultation with the Director of Environment and Cabinet member for Environment to make and sign the Extension Orders.
