

## **Record of Delegated Executive Decision(s)**

### **1. Subject of decision**

Future Construction Options – Main Fleet Vehicles and Racking Procurement  
Authority to procure and award contracts to successful tenderers for fleet and racking.

### **4. Executive summary**

The purpose of this report is to seek approval for the award of contract for the main fleet vehicles and racking provider.

At its meeting of 27 September 2017 Cabinet agreed that the Deputy Chief Executive, Head of Environment Housing and Leisure, Head of Commissioning and Investment, Head of Finance and Head of Law and Governance (whose delegations relevant to this Report are presently discharged by Senior Manager, Legal Services & Information Governance), in consultation with the Deputy Mayor, the Cabinet Member for Finance and Resources and Cabinet Member for Housing and Transport conclude any arrangements required to implement the recommendation to bring the housing, repairs and maintenance service in-house.

As this matter relates to the procurement of fleet vehicles and racking this matter falls within the remit of the Head of Environment, Housing and Leisure.

In accordance with the decision of Cabinet in September 2017 a procurement exercise has been undertaken by the Head of Environment, Housing and Leisure and this report seeks authority to award the contract for the main fleet vehicle and racking provider.

### **5. Alternative Options considered**

Leasing arrangements were considered however discounted as cost prohibitive.

## 6. Decision(s)

To approve the tender process and award:

- (1) the contract to Bidder B for six vehicle types and Bidder A for one vehicle type as identified in the Appendix 1 to the report “Main Fleet Evaluation Summary” as the bidders who provided the most economically advantageous tender for the main fleet of vehicles; and
- (2) the contract to Bidder B as identified in Appendix 2 to the report “Racking Evaluation Summary” as the bidder who provided the most economically advantageous tender for the provision of racking for the vehicles.

## 7. Reasons for the Decision(s)

To allow vehicles and racking to be purchased for the transfer of the housing, repairs and maintenance service.

The Authority would need to hire vehicles in the interim period which would increase costs.
