PART 1

1.1 Executive Summary:

This report seeks a delegated decision to advertise a proposal to establish and, in the event that no objections are received, proceed to establish three pedestrian crossings on B1322 Station Road in Backworth and Shiremoor.

1.2 Recommendation(s):

It is recommended that the Director of Regeneration and Economic Development:

- (1) agrees that notices for the proposal should be prepared and advertised in line with relevant statutory requirements; and
- (2) agrees that, if no representations are received following the period of consultation, pedestrian crossings shall be established in accordance with the proposal.

1.3 Forward Plan:

Seeking delegated decisions to advertise proposals to establish a pedestrian crossing and, in the event that no objections are received, to determine if a pedestrian crossing should be established is a standing item on the Forward Plan.

1.4 Council Plan and Policy Framework

The proposals in this report relate to the following priority in Our North Tyneside, the Council Plan 2021 to 2025:

- A green North Tyneside
 - We will publish an action plan of the steps we will take and the national investment we will seek to make North Tyneside carbon net-zero by 2030

1.5 Information:

1.5.1 Background

The Authority has obtained grant funding from the Government's Transforming Cities Fund (TCF) for the 'Routes to Metro' project to improve local cycling, walking and wheeling links which support accessibility to Metro stations.

The proposals associated with this report involve improvements to cycling, walking and wheeling links to Northumberland Park Metro station from the Backworth area.

The full scheme involves proposals for road humps, a reduced speed limit and three new crossing points. It has been designed to ensure that highway conditions are conducive to support greater usage of cycling, walking and wheeling.

1.5.2 Proposal in relation to pedestrian crossings

It is proposed to establish new toucan crossings at the following locations:

- Station Road, Backworth
 - a. At its northern western with A186, from the south western kerblines of Station Road, in a north easterly direction to the north eastern kerblines of Station Road
 - b. At its south eastern junction with A186, from the south western kerblines of Station Road, in a north easterly direction to the north eastern kerblines of Station Road

It is proposed to remove the speed cushions prior to the existing zebra crossing. A raised zebra crossing will then be installed at the existing crossing location:

- Station Road, Backworth
 - a. At a point 67m south of its junction with Church Road, from the western kerblines of Station Road, in an easterly direction to the eastern kerblines of Station Road

The proposed introduction of the new pedestrian crossings will facilitate crossing the road when travelling by more sustainable modes and contribute to ensuring that highway conditions are conducive to support greater usage of cycling, walking and wheeling.

1.5.3 Consultation

Engagement on the full scheme was carried out in Summer 2021, via a news item on the Authority's website linking to the 'Placechangers' consultation website. Feedback from this engagement informed the process of detailed design.

Letters have been issued to households in the area to set out the elements of the proposed scheme. The Cabinet Member for Environment and ward members have been updated on the proposals.

Arrangements have been made to contact the standard technical consultees in writing to advise of the proposals.

The statutory consultation process is set out in the Road Traffic Regulation Act 1984 and the Regulations that flow from that Act, namely, The Traffic Signs Regulations and General Directions 2016. The authority which makes the proposal is required to consult the chief officer of police about its proposal and give public notice of the proposal.

In North Tyneside, in addition to being advertised in a local newspaper, notices advertising the proposal are displayed on the Authority's website and on roads affected by the order. Documents relating to the proposal are also available for public inspection at the Authority's offices at Quadrant. Objections to the proposal may be made within a period of 21 days starting from the date the notice was published.

In accordance with the Authority's scheme of Delegation to Cabinet Members, if any objections cannot be resolved, then the Cabinet Member for Environment is asked to consider those representations made and not withdrawn and to determine if a pedestrian crossing should be established.

1.6 Decision options:

The following decision options are available for consideration by the Director of Regeneration and Economic Development:

Option 1

To approve the recommendations as set out in paragraph 1.2 above.

Option 2

Not to approve the recommendations as set out in paragraph 1.2 above.

Option 1 is the recommended option.

1.7 Reasons for recommended option:

Option 1 is recommended for the following reasons:

The proposals will increase safety for all road users and contribute to ensuring that highway conditions are conducive to support greater usage of cycling, walking and wheeling.

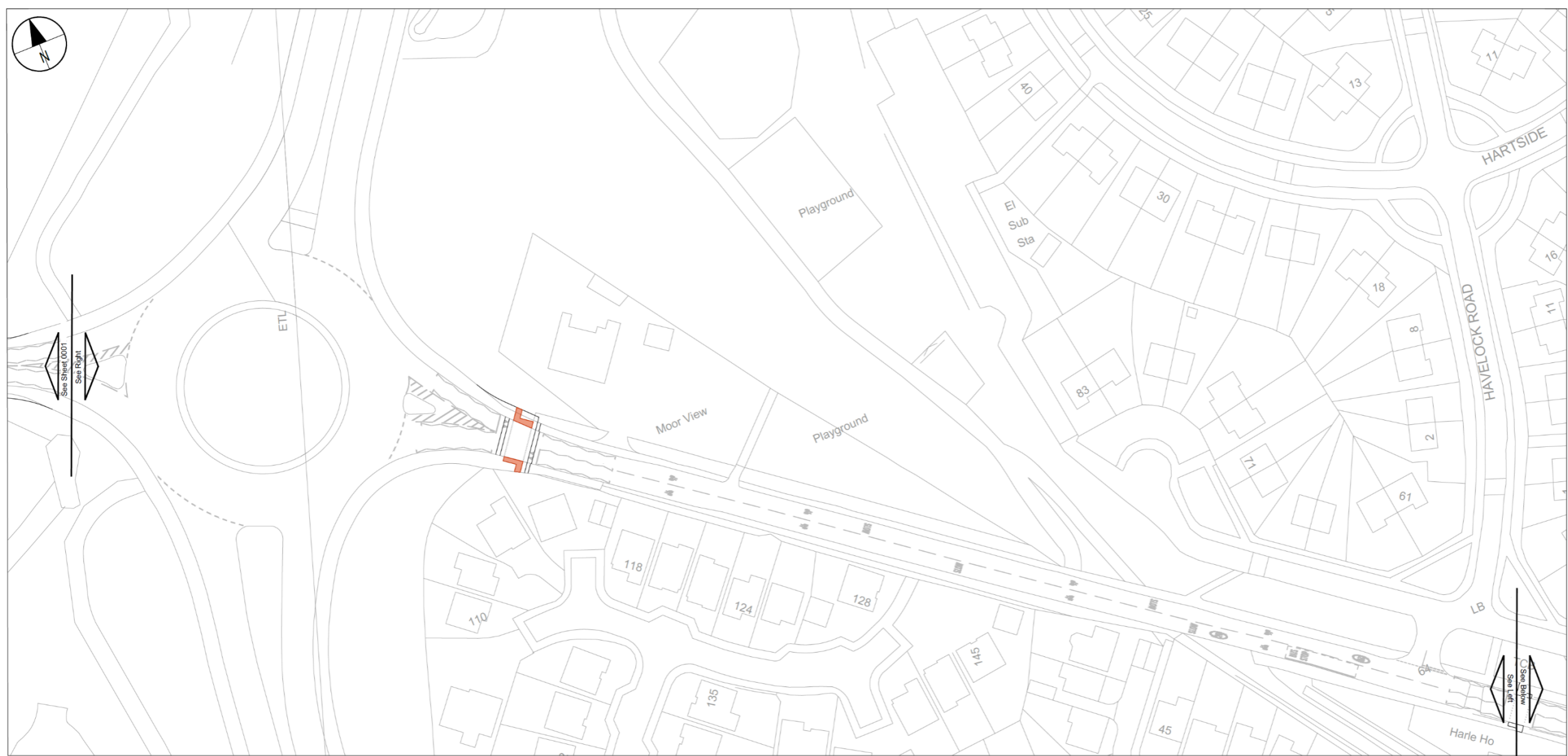

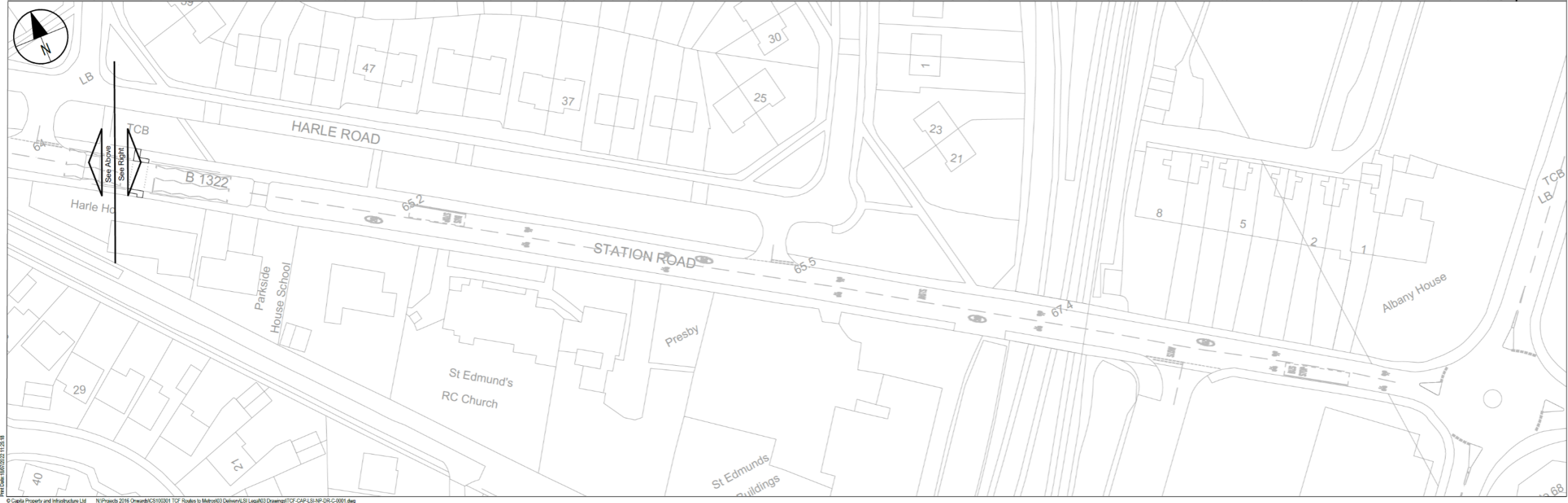
